

FHA Refund Fraud Alert on Loans signed after Sept. 1983

a Federal Housing Administration (FHA) single family mortgage insurance premium refund or distributive share REALTOR ® payment. These firms attempt to match a homeowner with the government funds owed, as part of a private relationship that the tracer is trying to establish. It is up to the third-party tracer to develop their client relationship and to ensure receipt of their fee. The Department is not a party to any agreement, financial or otherwise, between third-party tracers and their clients.

Since the Freedom of Information Act (FOIA) of 1986, listings contain public information, HUD cannot prevent individuals or organizations from utilizing this data for their own financial interest. However, the Department neither promotes the commercial use of these listings nor reimburses third-party tracers for any losses that they incur in locating claimants. HUD neither encourages nor discourages the efforts of thirdparty-tracers, as long as the tracers do not misrepresent themselves or the process to the public.

You should be careful about any literature or solicitations stating that a change in HUD's, FHA's or the government's policy will prevent you from receiving your refund and that you should call their office immediately. You should be aware that there are firms that might claim that you must refinance your loan in order to qualify and/or quote some large refund available to you if you refinance your loan with their firm. If you are unsure whether your loan was FHA, you can call HUD on 1-(800) 697-6967 and provide your name and property address, or you may contact us at sf_premiums@hud.gov. Please be advised that the Department does not sponsor any Third-Party Tracer Programs.

Hurricane Season is Here!

As a reminder, it is recommended that you have on hand a...

<u>DISASTER SUPPLY KIT (DSK)</u> - Here in Jacksonville history has proven our greatest threat is power outages. Your DSK should include, per person, for 3 to 7 days the following:

- At least 1 gallon of water daily, non-perishable packaged or canned food/juices, snacks, infant and senior friendly foods, non-electric can opener, paper utensils and toiletries, cooking tools and fuel, blankets and pillows and pet care items if appropriate.
- First Aid Kit, including prescription drugs, medicine, band-aids including ace bandages and ointments.
- Cash (with small bills) and Credit Cards, Keys, Fully charged cell phone with extra battery, battery operated NOAA weather radio, flashlights and batteries, seasonal clothing and rain gear, important documents and fill vehicle fuel tanks. (Note: When cell phone towers are down and you can't get a signal, text messaging is an alternative method to communicate with loved ones so learn how to text)

I had someone come to my house to help me with my spring cleaning. She showed me a trick and it is amazing so I wanted to share it with you. When cleaning glass or mirrors take a wet paper towel or clean rag and add Dawn dishwashing liquid. Wipe on the surface and then wipe off with a clean dry paper towel and it is sparkling clean, no streaks or spots. I have always used a window cleaner, but this is so easy and leaves the surface shining with little effort. You can also mix water and Dawn in a spray bottle. You don't need a lot of Dawn so it is inexpensive too. Hope you find this hint helpful.

You can make your own furniture polish by mixing 3 to 1 part Olive Oil and White or Apple Cider Vinegar. Mix well and apply with a clean cloth to wood, but do not use on unfinished wood or lacquer.

Cleaning blackened pots made easy. If you have pots that have blackened because you boiled water in them, soak the pots with a pot of water in them to which you add 2 denture tablets. Let them soak overnight. The pot should be clean in the morning. Wash before using.
