Located on Highway 70 in Donley and Hall counties, Bitter Creek is well known for its hunting with extensive quail, dove, turkey, whitetail and mule and excellent fishing can be found in the ranch's two stocked ponds. The extensive improvements include several homes, hunting lodges and camps.




### (Dec.) ONE SOTHEBY'S INTERNATIONAL REALTY | \$26,500,000 | FLORIDA, USA
